No vendor will be allowed booth set up on event day without previous submission of vending fees. Booth fees must be prepaid and cannot be accepted on the day of the event! Advertising artwork received may be resized to fit in the space allotted and must contain the name of the business and website or physical address. If advertising artwork is not received by August 1, 2009, an ad will be built using logos and information found on the internet. If your ad contains a coupon or other tear-out, please indicate this when emailing your art to saltlakeppd@gmail.com.

All vendors receive a free listing in the Event Guide business directory that contains the name of the business and website or physical address. A phone number may also be included if it is available. Non-Profit Vendors also receive a free 1/8 Page advertisement. Larger sized advertisements may be purchased at full price.

All Trade agreements must be approved by a Salt Lake Pagan Pride Local Coordinator.

The Inside Front Cover, Inside Back Cover and Back Cover are premium placement locations and must be re-quested and paid for separately.

Pre-payment and pre-registration is required for all vendors. Collection and payment of UT state sales tax is the sole responsibility of the vendor. Vendors must supply their own set-up display, chairs, and canopy/tent. No re-funds will be given at any time, for any reason, including personal or weather related issues. The event staff, sponsoring groups, and/or the city of Murray are not responsible for lost or stolen items or any damages incurred on the grounds of the event. The event staff is not responsible for setup, tear-down, working or helping vendors' staff tables or tents.

Salt Lake Pagan Pride will do its best to separate vendors selling the same types of items. We cannot, however guarantee that similar businesses will not be placed next to each other, nor that any competing businesses will be barred from vending at the event.
