- You must register and submit your vending fee to the Salt Lake City Pagan Pride Day Vendor Coordinator no later than August 27, 2010. Booth fees must be prepaid and no vendor will be allowed booth set up on the day of the event without prepayment of the vending fee.
- A temporary Sales Tax License will be issued to each vendor on the day of the event in accordance with state law. Collection and payment of Utah State Sales Tax is the sole responsibility of the vendor.
- Vendors must supply their own set-up display, chairs and canopy/tent.
- The event staff is not responsible for set-up, tear-down, working or helping vendors staff their tables or tents.
- Salt Lake City Pagan Pride, Inc., its Board of Directors and/or employees, and the event staff, sponsoring groups, and the city of Murray are not responsible for lost or stolen items, or any damages incurred on the grounds of the event.
- All Trade Agreements must first be approved by a Salt Lake City Pagan Pride Day Coordinator
- Salt Lake City Pagan Pride will do its best to separate vendors selling the same types of items. We cannot, however, guarantee that similar businesses will not be placed next to each other, or that any competing businesses will be barred from vending at the event.
- Booth placement will be assigned to maximize pedestrian traffic through the booth area. We will take all special requests for booth placement under consideration. However, we cannot guarantee that we will be able to grant it. A map of the booth area will be provided via email prior to the event.
- For promotional purposes, Salt Lake City Pagan Pride may conduct interviews or take photographs and/or recordings of the event, its participants and vendors.
